# PARISH COUNCIL MEETING Held in Wigginton Village Hall Tuesday 21<sup>st</sup> December 2021 at 8 pm

## **MINUTES**

#### 1. Chairman's Welcome.

The Chairman welcomed everyone and opened the meeting.

#### 2. Apologies for absence to be considered by the Council.

The Council accepted apologies sent by Cllr Axon, Cllr Maisey and Cllr Grammenos.

## 3. Declarations of Interest and Dispensations.

#### 4. Public Participation.

- 1. Member of the public spoke about 21/04243/FUL Demolition of existing house, construction of two-storey replacement dwelling. Amberley Hemp Lane Wigginton Tring Hertfordshire HP23 6HF. The Parish Council voted not to comment on this planning application.
- 2. A working party consisting of Cllr O'Sullivan, the clerk and a resident will schedule a site meeting with County Cllr Symington and HCC Highways representative to discuss traffic and speeding around the village. Discussion deferred until January 2022.
- 3. County Cllr Symington will investigate about the speed and volume survey results carried in Wigginton.
- 4. County Cllr Symington suggested for the Parish Council to create a wish list for traffic and speeding measures to be implemented around the parish.
- 5. County Cllr Symington reported about Dacorum Local Plan and call for sites. She reported that HCC had put forward a piece of land in Wigginton for consideration.

#### 3. Ground maintenance contract.
