# 22/32 Wigginton Community Projects.

22/32 1. Planting Trees project.

Cllr Maisey obtained two quotes and had been investigating different types of trees. He suggested for the Parish Council to plant a copper beach tree. The pre-school agreed to join in with this project. Cllr Maisey suggested for the WI to plant well establish tree and will send suggestions to the WI representative. The Parish Council resolved to have one commemorative plaque. Work in progress.

22/32 2 Big Picnic.

The risk assessment was circulated prior to the meeting by Cllr Stillwell and was approved by the Council, subject to minor additions. The Clerk will let the PCSO know about the Big Picnic taking place on the Sports Field.

# 22/33 Warden's Report.

The warden's report was circulated prior to the meeting. The warden was present at the meeting and answered questions from members in relation to his report. The council discussed and agreed on the following:

- 1. 4 village benches had been pulled out of the ground and remain unsteady. Council is waiting to appoint a handyman.
- 2. Wooden post with the dog bag dispenser is wobbly.
- 3. The Council approved unanimously to fit a wooden gate at the entrance to the Sports Filed.
- 4. Graffiti had been sprayed on some non-parish assets. The Clerk will contact UK Power Network and BT where the graffiti is visible asking for it to be removed.
