20/03155/FUL Creation of two patio extensions with seating, one with slabs to the north and the other with a bark chipping surface to the west, for the use of Wigginton Village Shop and the community, and for the erection of 3 fixed umbrellas. Wigginton Community Shop Chesham Road Wigginton Tring Hertfordshire HP23 6HH The Council discussed this application in detail and took into consideration comments submitted from residents. Member of the public raised objection and spoke about negative impact of the extension to the patio.
