It is understood the verge is being used for parking, despite previous soft verge repairs completed in December 2022. WPC may wish to consider/decide if it is worthwhile submitting a further repair request to HCC.</li> </ul>
19. Large pothole next to residential property 'Pippins' (Wigginton Bottom) reported to HCC (Photo 10). Ref No: 401003420387.
